Under the Health Insurance Portability, and Accountability Act (HIPAA) Privacy Rule the HBP can only release your protected health information for purposes of treatment, payment, or healthcare operations. Completing a Personal Representative Authorization form allows the NALC HBP to release protected information to those family members, or friends who may contact the Plan on your behalf if/when you are unable to do so.. Keep this information current by completing a new form every two years. ### Preparations for 2013 Food Drive Under Way

Hundreds of NALC branches throughout the country are preparing now for the 21st annual NALC Food Drive, which will take place on Saturday, May 11. "On the second Saturday in May, letter carriers once again will proudly lead the country's largest single-day drive to help fight hunger in America," NALC President Fredric Rolando said. "What we see on our routes drives us to do what we can to help millions of Americans get the food their families so desperately need, and I once again call on every active and retired NALC member to get started now to prepare to make this coming drive another successful one."

### Opinion Refutes USPS Claim on Cutting 6-day Mail

Postmaster General Patrick Donahoe's claim that the Postal Service has the right to cut its mail delivery schedule from six days to five days "rests upon a faulty USPS premise," the Government Accountability Office (GAO) said in a legal opinion released March 21, adding that there is no legislative authority from Congress allowing the change. The GAO agrees with an ever-growing chorus of voices that the postmaster general doesn't have the law on his side in this matter.

### Senate, House Pass CR with 6-Day Language Intact

On March 20, the Senate approved its version of a continuing resolution (CR) to fund the government through the current fiscal year, ending Sept. 30. (The current CR expires March 27.) **The language mandating six-day-a-week mail delivery was retained.** The House passed the measure on March 21 unchanged, and President Obama signed it into law on March 26. Note that this will only preserve Saturday mail in the law **through Sept. 30**, and with Postmaster General Donahoe threatening to end Saturday delivery on his own in August, our battle to keep Saturday mail permanently continues.

### Retiree Cost-of-Living Adjustment (COLA)

The February 2013 Consumer Price Index (CPI) released March 15 showed a slight increase, so the accumulation toward the 2014 retiree cost-of-living adjustment (COLA) now stands at **0.8 percent**.

### EAP Website for Postal Employees

Magellan Behavioral Health, the contractor providing the Postal Service with Employee Assistance Plan (EAP) services, has created a free, informative, new website for postal employees. Letter carriers may join the site by surfing to [EAP4you.com](http://EAP4you.com), clicking "New User," entering 800-327-4968 and registering with an anonymous user name and password. The site contains a huge storehouse of up-to-date health and wellness information on everything from coping with workplace stress, to child and elder care, to time and money management, to learning the warning signs of substance abuse. It also offers an "ask the expert" section for customized advice, anonymous self-screening tools for such problems as depression and alcohol abuse, and a wealth of links to Internet resources on all things related to personal or family health.

### Boosted by Strong Market, TSP Funds Make Gains in March

After a modest showing so far this year, Thrift Savings Plan funds were buoyed by recent record highs on Wall Street and finished the month with solid gains. All five regular funds, in addition to the target-date Lifecycle Funds, finished March in the black for the first time since November, according to data provided by the Federal Retirement Thrift Investment Board. In March, the C Fund (designed to match the performance of the S&P 500) and the S Fund (stocks of U.S. companies not included in the S&P) posted the largest gains. The I Fund, which is tracked to international stocks and which fell by nearly 1 percent last month, dug itself out of negative territory and posted a slight gain of 0.88 percent. All of the L Funds, a mix of fund investments targeted to when participants will begin withdrawing funds from their accounts, bested last month's performance, although not quite reaching the highs of January's returns. The G Fund lived up to its sure-and-steady reputation, posting an ever-so-slight gain of 0.13 percent — as it has for the past three months. Over the past 12 months, the G Fund is up by 1.46 percent, the F Fund (representing the bond market) up by 3.98 percent. The C, S, and I Fund are all up by double digits year-to-date: 13.98 percent for the C Fund; 17.16 percent for the S Fund; and 11.59 percent for the I Fund. Overall, the stock market is experiencing one of the "strongest bull markets in a half century," according to
