

## Presidents Report

Well Brothers and Sisters, I have more good news to report for our Deptford/Woodbury Steward who I informed you of last month. Thanks to the work of our National Union and the case file put together by our Stewards in the Deptford Installation, and a **non-biased** advocate from labor relations, our steward has returned to work in Deptford with full back pay and benefits. The union advocate felt strongly in getting this case overturned in its entirety, but agreed to settle it before the arbitration hearing with basically a 7-Day Suspension removed in 4 months. We constantly told the local manager this case was not a removable offense, but the postmaster refused to look at this case with a clear and unbiased head, and decided to risk all the money of the postal service in moving this case forward. I am not sure how much money the postmaster cost the postal service, but the hours of just the union time involved was immense. I wonder if the postal service held their managers accountable for all of this wasteful spending, they would think differently? I can't imagine how the manager's bosses can just accept this loss of time and money with no repercussions! I constantly hear the POOMS telling their managers to keep pressuring the carriers to work harder because they are "stealing" from us! How about start policing your own incompetent managers who are the real thieves in this company. After this decision was rendered we had hoped the incompetence would stop in this office, but I guess there are sour grapes that still remain. It amazes me how they want to blame labor for not taking this case to hearing! We finally got someone in labor that saw this case was a loser and decided it was time to stop the bleeding! The people involved from the beginning made this a personal case, and got their vision blurred because of who was involved. Justice has been served, even though we had to wait for over 6 months to get it. I hope the district starts to look at their managers who take things personal and refuse to manage without bias! In an installation this size, there needs to be someone who wants to work with us and not manage in a covert way. Stay tuned for more nonsense from Deptford because it isn't over.

On another front, we continue to be in Article 12, but again, hopefully it will be ending shortly. Also, many of you have heard of the Trump edict on freezing new hires. Fortunately, the Office of Management and Budget has clarified the edict. Among the clarifications – hiring by the US Postal Service is *not* included in the freeze. So hopefully we can get our offices fully staffed.

Speaking of the contract, I attended Branch 38's training seminar last month and President Rolando stated he was hoping on having an answer to the agreement by the end of January. He still remained very positive an agreement was imminent, but was just ironing out a few details.

One last item I must mention is the treatment the district is showing to our craft. The POOMS in their daily telecoms are constantly berating offices who are not issuing discipline to carriers for everything possible. Miss an MSP, discipline the carrier. They state there is, "no excuse and it is an easy win for us!" They are stating the carriers aren't working and are "stealing time!" This disrespect is the core problem of why the morale is at an all-time low. The stuffed shirts and skirts better start focusing on letting us do our job and go out on the street and find new work for us to do, not look for carriers who wheels may not be curbed enough.

Calling all CCA's. Keep abreast of your benefits, options, and rights. It's easy to do by downloading the NALC member app, and opening the CCA resource guide. Any CCA's converting to career I urge you to look at the NALC HBP High Option as it is very competitive with premiums, outstanding coverage, and low out of pocket expense. Call me anytime for more info, or questions at 856-304-8665. You only have 60 days from date of conversion to make changes. You must have your PIN number to access your file. If you don't have one call shared services to request a new one ASAP. Anyone having problems with accessing their account to make changes in your health benefits, I do have paper copies to do it the good old fashioned way.

The HBP has released a list of new changes for 2017 for all plan options. They can be found at [nalchbp.org](http://nalchbp.org). Click on Directors message to see the changes. Although few, do yourself a favor, and check to see how they may affect you.

Any needs for additional life insurance, retirement savings, hospital plus insurance go to [nalc.org](http://nalc.org). Under member benefits click on Mutual benefits. Here you can find any plans to suit your needs. I urge CCA's to look at the savings offered to you to help plan retirement. All funds are easily transferable to your TSP when converted.

On January 22nd, President Trump issued an executive order to all federal agencies to freeze hiring new employees, however NALC President Fred Rolando said on January 28th's e-activist report that he and his staff are still getting answers through the postal service about the language of the statement Mr. Trump addressed. Also, President Rolando said if he hears any new developments on this matter, he will let us know immediately. In other news, the latest House Resolution bill tracking update was issued in this same e-activist report. HR-15 (6-day delivery) has 50 cosponsors, HR-28 (door-to-door delivery) has 84 cosponsors and HR-31(service standards) has 28 cosponsors. A cosponsor represents an individual in the senate who is for us and supports a particular bill. Remember, we have not only a brand new president, but a brand new senate too. As we get to know these new faces and names, we cannot stop fighting and we need to continue to push our strong Letter Carrier platforms to every corner in legislation. Finally, I want to thank our latest contributors to the LCPF, Eric Burgess, Ryan Dixon, Ray Fuller, Gary Maneely and Mike Rofrano. ### **Ozzie Lecky - Letter Carrier Political Fund Chairman**

*\*(By making a contribution to the LCPF, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the NALC or of employment by the USPS, nor is it part of union dues. You have a right to refuse to contribute without any reprisal. The LCPF will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the LCPF are not deductible for federal income tax purposes. Federal law prohibits the LCPF from soliciting contributions from individuals who are not NALC members, executive and administration staff, or their families.)*

### **GOP Bill Would Eliminate Union Representation and Other Protections For New Postal Workers**

A bill introduced by GOP congressional representative Todd Rokita of Indiana would eliminate civil service protections, including the right to union representation for all new federal employees, including new postal workers.

A key provision of Rokita's "Promote Accountability and Government Efficiency (PAGE) Act" states:

Notwithstanding any other provision of law, any employee in the civil service (as that term is defined in section 2101 of title 5, United States Code) hired on or after the date that is 1 year after the date of enactment of this Act shall be hired on an at-will basis. **Such an employee may be removed or suspended,**

**without notice or right to appeal, from service by the head of the agency at which such employee is employed for good cause, bad cause, or no cause at all.**
