## Presidents Report

Well brothers and sisters, it just won't be the heat we will have to deal with this summer, it appears the district is ramping up its pressure on all carriers to try and force feed this new P.E.T. program on everyone. Their latest harassment techniques is now telling carriers every morning what their street times will be, not what the carriers expect it to be. They are not even engaging a conversation with the carrier, who may not agree with their assessment. It has become the old deliver all the mail and be back on time, and pick up a half hour under-time as well. They are trying to use the one-day walk time (3999) to hold every carrier to their so called "demonstrated performance!" I will continue to remind everyone every month, as long as management tries to intimidate the workforce, that there is no such animal in any manual that says management can hold anyone to a one-day walk time or a "demonstrated performance." They can produce all their stupid little reports that they have their supervisors look at each day to try and beat you down with, but the bottom line is each day is a different day, and "YOU" make your assessment of your workload, not some silly little report they throw in your face. If you are going to be late fill out a 3996, and don't let them tell you it is not necessary. If they want to hold us to every little thing, we must do our job properly and submit all the proper paperwork in order to protect our rights. Their reports don't take into account weather conditions, etc. Remember to be extremely careful with the heat this summer, and let your managers know if you are struggling. It is better to be safe and take a little longer, than to skip your breaks and lunch and suffer from possible heat exhaustion.

I have to mention one other item in regards to this new program the district is pushing. It really bothers me that the local managers are being told to issue at least 5 pieces of discipline a week for carriers who aren't making their "demonstrated performance!" I know the district leaders will deny ever saying this, but trust me when I tell you they are saying these things. If this isn't the most pathetic form of managing I have ever been associated with, then I can't recall anything as idiotic. We work with a bunch of hypocrites! I go to these meetings with the district manager and the POOMS, and they ask for our input on how to make things run smoother, and this is the result of our conversations? The morale in this district is at an all-time low and will continue to erode as long as the leadership in this district continues to treat its employees this way.

On a different front, many of you are aware our contract expired on May 20<sup>th</sup> and as of this writing we are still talking in hopes on getting a negotiated agreement. Unless something drastic happens, I would expect we will probably end up in arbitration. President Rolando has stated he will not agree to any contract that doesn't reward our craft for all we have done to keep this organization afloat. Make sure you sign up as an e-activist so you can keep track of all our issues this summer. Hope to see everyone at our last meeting until September. Keep up the fight!

### School's Out – Please Drive Safely

School bells will soon be silent and once again youngsters will be in the neighborhoods during the time we deliver mail. For drivers, this means more possibilities of unwary young pedestrians wandering into roadways or darting from between cars or hidden places. This is a true test of anyone's defensive driving skills!

In spite of all the training children receive at school, and in spite of parental instruction and admonishment, some children do play in the street. Most dangerous, perhaps, are those who play merely *near* the street, leaping out suddenly after a ball or chasing a dog.

We are all familiar with the necessity of caution near playgrounds, but we should take care also while driving in residential areas or anywhere else. Remember the following things:

- Whenever you see a ball rolling in the street, you are likely to see a child following it. Slow down and prepare to stop quickly.
- When the ice cream vendor starts into the neighborhood, watch for children coming from all directions.
- Pay attention to the lone child walking along the street. You are much more unlikely to overlook a single youngster than several together.
- Children and others on roller skates, skateboards, or roller blades can roll into the street. They require your extreme alertness.
- Bicyclists, especially young or novice riders should be watched carefully and provided plenty of room.
