### Presidents Report

As most of you know we just participated with the three other unions in a rally to save the postal service on September 27<sup>th</sup>. We had a great turnout considering the time of day it was scheduled, which ran from 4 till 5:30pm. I was quite pleased with our branch turnout at Congressman Andrews's office in Haddon Heights. We had roughly 45 of our member's turnout after work where approximately 130 other union members and their families attended. Once again it was the carrier craft that made the majority impact. We had approximately 100 of the 130 in attendance. It goes to show what craft really cares the most about our jobs. WE also had approximately 1600 postal workers state wide that also participated in the rally, which was a great showing considering. Anyhow, it was a great event that occurred nationwide in 492 congressional districts throughout the country to spread the word about what needs to be done to save our jobs and the postal service. The one thing that ceases to amaze me is how little some of our members knew of this rally. We have been hyping this for the last month, and unless you have been under a rock, you should have known about this. I hope our members start to wake up and pay attention to what is going on around them. It is important to start to get involved in our job and what you can do to help keep it thriving. The days of sitting on your hands and letting someone else take care of business is over. Start getting involved and attend your union meetings and become an E-activist, give to COLCPE, to keep in tune with what is happening in the postal service. We are entering a crucial time with negotiations and legislative issues, and everyone needs to be educated on what is going on. I would also like to thank Brother **Mike Stanton**, president from Haddonfield, who helped organize the rally and made it a success. An issue which is surfacing in our district has the clerk craft coming over to the carrier craft to perform work in our craft. We haven't seen this occur as of yet in our branch, however, I have been told it may be happening shortly. We are prepared to file all the necessary grievances to stop this blatant violation of the contract, even though I have been told the district's policy is they don't care if this violates the contract and will do it regardless. I hope this is just posturing on their part, because this is no way to run a business. Stay tuned for updated info. I will be attending the NALC national rap session this month in Las Vegas and hope to get some updated info on our upcoming negotiations as well as bringing back information on the NALC Health Plan, which has their seminar in conjunction with the rap session. We also have branch elections this month, which will take place at the regular meeting on October 19, 2011. All positions are up for election and anyone who wishes to run must be nominated at this time. Hope to see to see everyone at this months meeting

### Notice Of Nominations And Election Of Branch Officers, Shop Stewards And Convention Delegates

This is to provide official notice that nominations for the election of Branch Officers, Shop Stewards and Convention Delegates for the term 2011 thru 2013 shall take place at the regular monthly meeting of the Branch on **Wednesday, October 19, 2011**. Elections shall be by secret mail ballot of the eligible Branch membership held as soon as possible after nominations at the October regular monthly meeting. Nominations shall be made from the meeting room floor or in writing to the Branch Recording Secretary, mailed or presented to him/her prior to or at the October regular Branch meeting. Each eligible member of the Branch nominated for office shall accept or reject nomination in writing prior to the adjournment of the October regular monthly Branch meeting. Failure to accept nomination for Branch office prior to adjournment of the October regular Branch meeting will invalidate the nomination. Shop Stewards shall be nominated by an eligible Branch member from the office at which the nominee is employed to represent the Branch membership. Installation of Branch Officers, Shop Stewards and Convention Delegates shall take place at the regular monthly meeting of the Branch in January. Offices up for election include that of the Branch President, Vice President, Recording Secretary, Treasurer, Financial Secretary, Assistant Recording Secretary, Trustees' Chairman, Trustees (4), Health Benefits Representative, Housing Chairperson, Sgt. at Arms, Shop Stewards (37) and approximately (36) Convention Delegates. The number of Convention Delegates to be compensated for their attendance at a State or National Convention, provided they meet the eligibility requirements for such compensation, shall not exceed two and one half (2.5) percent of the total Branch membership, (which is approximately 18).

### Mailing and Return Of Branch Election Ballots

Branch election ballots will be prepared and mailed out by the Branch Election Committee on **Wednesday, November 2nd** for completion and return to the Election Committee by **Wednesday, December 14th**. The results of the election will be announced by the Election Committee at the regular monthly meeting of the Branch on **Wednesday, December 21st**.

### Not a Done Deal: NALC Vows to Oppose 5-day Delivery in Obama Plan

President Obama sent a deficit-reduction package Sept. 19 to the special joint committee of Congress established by the debt limit law to find ways to reduce the federal budget deficit. The package included a number of reforms to address the financial crisis at USPS. We are both encouraged and disappointed. We are encouraged that President Obama is attempting to creatively address the USPS cash crisis through the deficit reduction process and welcome his proposal to return the \$6.9 billion postal pension surplus in FERS to the Postal Service as proposed in Rep. Stephen Lynch's H.R. 1351. But we are very disappointed that the administration opted for a deferral of the next two pre-funding payments (\$5.5 billion each) instead of embracing a permanent reform based on the Lynch bill's recovery of the even larger CSRS surplus. And we deeply regret that the administration has given into pressure from the postmaster general and has proposed to eliminate Saturday mail delivery. The NALC has carefully examined the various elements of the White House plan. It is important to remember that these are just proposals; they cannot become law unless Congress adopts them. We want to assure our members and all those who are interested in preserving the U.S. Postal Service that we will work with everyone involved, including members of the joint congressional committee, to build a strong Postal Service that will continue to provide exceptional service to the public six days a week.
